This is the final time I will write to you in this manner. After three years as President of the Board of Directors, I decided the time had come for me to step aside. It is our good fortune that Meridith Murray, the daughter of former President Arthur Buehler and a Vice President of the Board, took over the reins as President. Meridith's passion for SHORE and her commitment to our future are unquestioned.

We are truly blessed to have had 444 volunteers spend over 11,000 hours around the agency. Where would we be without that commitment? And it turns into a win-win for all concerned because of the interaction between the volunteers and persons served.

During the year, SHORE was fortunate to have three companies, Schwarz Paper Co., C.H. Robinson Worldwide and IMS, in conjunction with an agency called Rebuilding Together, supply over 150 volunteers in assisting in multiple labor intensive improvement projects at the Joseph Koenig, Sr. Training Center in Morton Grove and at the Lois Lloyd Center in Evanston. In addition to their handiwork, they underwrote the costs for the projects.

The Panoptic Corporation redesigned SHORE's website, and the year before produced a new video, both to rave reviews and underwritten by the company. I would be remiss if I did not acknowledge the Board of Directors and the over 60 volunteers at the agency's re-sale shop Second Time Around Thrift and Gift Shop in Skokie, which is run by Volunteer Manager Meridith Murray. Their time and hard work on behalf of the agency has been invaluable and brings in much needed revenue for the agency. 
SHORE continues to serve over 380 children and adults with developmental disabilities yearly. Our Early Intervention Program, focusing on children from birth to three years of age, is a real success. With an enrollment increase of 13, to 80, the primary goal is to bring these youngsters to the point where each has a chance to be ready to be assimilated into public or private schools.

The Joseph Koenig, Sr. Training Center served 191 trainees. Twenty-two received Supported Employment services. Over \$200,000 was obtained in contract work, but the best part is the valuable experience gained by these trainees, more than worth its weight in gold.

Fifty-six adults call SHORE home in the numerous residential programs available, while 77 adults attend the Adult Services Program at the Lois Lloyd Center in Evanston. There were also 23 families served by the In-Home Respite Program.

Finally, thank you to all the individuals, companies, foundations and area organizations that have generously supported SHORE over the years. We would not have been able to provide quality programs without your help. I have been privileged to serve as SHORE's President and will always be grateful for your support.

Programs & Achievements

Vocational Programs

SHORE Joseph Koenig, Sr. Training Center is a vocational program supporting persons with developmental disabilities ages 16 years and older. The program seeks to enhance the individual's ability to obtain and maintain employment. Objectives include: providing employment, maintaining job performance and improving job-related skills and habits to maximize earning potential. The Center utilizes community job sites and subcontract work from local industries to prepare individuals for employment. A Senior Services Program is also available for individuals (55 or older), who have chosen to retire. This program offers leisure-based and community activities.

- **191 individuals served during the year.**
- **The Sales Department reached over \$240,000 in contract work from businesses in the community, which is an increase of 36% from the previous fiscal year. Midwest Can and Container Co. was a significant new customer with over one million gas can spouts produced for them.**
- **A new partnership was created with Mathers Lifeway in Evanston, which provides trainees with community work experiences.**
- **22 persons served in the Supported Employment Program.**

Residential Services

SHORE offers three distinct residential programs. The Buehler House - SHORE Homes East in Evanston, and SHORE Homes West in Skokie house 12 residents at each site in a 24-hour staff supported living environment as similar as possible to life in mainstream society. Residents are encouraged to interact with their community and to learn and to become less dependent on others. All residents are engaged in daytime employment, training or senior leisure programming.

Community Integrated Living Arrangements (CILAs) are homes in the community where two to six people reside. There are two located in Skokie and one in Evanston. The program consists of an array of services designed to meet the needs of each resident on a long-term basis. Staff support is available on a 24-hour basis. Residents attend one of SHORE's day programs during the week.

The Patricia Lloyd Townhomes in Evanston and scattered-site apartments in Evanston and Skokie comprise SHORE's Supported Living Arrangements (SLA) program. The Patricia Lloyd Townhomes are a row of five two-story units, each housing three individuals that are available to adults who are able to live more independently. Twelve individuals live in the homes and most are employed in the community. Residents are responsible for themselves and their homes. House Managers reside in one unit to provide support as needed. The scattered-site apartment residents have intermittent contact with staff. Services are on an as-needed basis and training includes: budgeting, housekeeping, cooking, shopping, and transportation; and interpersonal counseling and case management are provided.

- **During the fiscal year, 56 individuals received services at the various residential sites. Program emphasis at all residential sites was on promoting a healthier lifestyle for the residents. Areas focused upon were diet/nutrition, exercise, mental stimulation, hobbies/leisure and hygiene.**

Adult Services

The Adult Services Program, which offers developmental training for individuals 18 years and older, is located at the Lois Lloyd Center in Evanston. Participants may have multiple disabilities, including severe/profound to moderate developmental disabilities, physically challenged and medically fragile. This day program teaches curriculum in the areas of language and communication, adaptive daily living skills and prevocational skills.

- **77 individuals were served in the Adult Services Program.**
- **Over 160 community integration activities took place at 56 different sites including trips to various museums, malls, zoos, restaurants and stores. Internal activities included: exercise, cooking, group music and dance therapy, wellness, literature hour, music appreciation, art activities, sports and recreation, and cinema. A professional hairdresser also provided haircuts to many clients.**

Early Intervention

Early Intervention (EI) serves infants to three-year-olds who are experiencing developmental delays. SHORE provides individual and group therapy (occupational, physical, speech, and developmental) and other services in a variety of locations such as our EI Center, the child's home, or day care. The primary focus of the program is the family and what is best for the child. Research has demonstrated that working on prevention type activities with children at a very young age is much more cost effective than remedial type programs with children at a later age.

- **80 children received Early Intervention (EI) services during the year.**
- **Three distinct playgroups are currently offered to help meet the developmental needs of the children served in the EI Program. They include: Occupational/Developmental therapy, Speech/Developmental therapy and Bi-lingual Developmental therapy.**
- **A grant was received by the Special Kids Foundation to fund bilingual playgroups in Spanish and Polish. Two regional CFC's (Child and Family Connections), make referrals of children to SHORE. Each CFC serves approximately 25% non-English speaking families.**
- **Target awarded the EI program a grant to fund a lending library. Children are able to take home the book used in the playgroup to help reinforce the skills learned that week. Usborne Books matched the grant with an additional 50% in books.**
- **Lekotek is an agency that works with young children with developmental delays and collaborates with SHORE's EI Program. They are currently housed at the EI Center.**

Respite Services

The purpose of the In-Home Respite Care program is to ease some of the stress families endure when they are the sole caregiver of a family member with a developmental disability. In-home training is provided that assists respite recipients with communication, self-care and social skills while enabling the primary caregiver to leave the home. Objectives are developed with the input from the individual, family members and staff, which are part of an individualized program plan. A family is usually assigned one respite worker to assure continuity. Hours for respite can range from a few hours every week, to weekends or additional hours as needed.

- **23 individuals received Respite services during the year.**

Agency Re-Sale Shop

The Second Time Around Thrift & Gift Shop, located at 4123 Oakton Street in Skokie, is a re-sale shop that sells donated gently used clothing, home décor, kitchen items and more. All proceeds benefit SHORE's programs and services. In fact, approximately \$60,000 was donated to SHORE in FY 2008. Over 60 dedicated volunteers run the shop, which is open Tuesday-Saturday 10:00 a.m. to 4:00 p.m. If interested in volunteering contact Meridith Murray at (847) 673-3172.
