Dear Friends of Shore:

As is often done at the end of a year and the beginning of a new one, I find myself reflecting Shore's Fiscal Year (FY) 2014, and look forward to our 64th year of providing services to children and adults with intellectual and other developmental disabilities. I am grateful and inspired by the dedication and resilience of Shore and its incredible staff.

Very early in our new fiscal year, our Executive Director, Debora Braun suffered a severe stroke. Foremost, as a friend and admirer of Debora, my immediate concern was for her recovery. As the President of the Board, my next thoughts and concerns were, of course, for Shore. As a newly appointed President, I had my doubts of my own abilities to take on such a challenge, but as most things work in life, when faced with such challenges, we rise to them. I am happy to report that Shore and its wonderful and extremely capable Directors and staff stepped up to the challenge and were able to manage all aspects of the agency in Debora's absence.

We now face one of the greatest challenges in Shore's history with the \$2,500.000 Challenge Campaign to purchase a new home for the Adult Services Program, which is currently located at the Lois Lloyd Center in Evanston and provides

developmental and prevocational training to over 80 adults. This purchase will also be home to our administrative offices allowing us to consolidate space and ultimately make great improvements and expansions to the programs and services offered by Shore.

The need for this new building initiated the launch of Shore's \$2,500,000 Challenge Campaign. The campaign is currently underway and in full speed now that a building has been acquired. Thank you to all who have participated in this launch and have made pledges to this campaign to ensure the future of Shore. Though our initial responses have been extremely positive, we still need everyone's support of this great project to meet our goal.

Business at Shore carried on as usual in 2014, thanks to the capabilities of the staff and dedication of the Board of Directors. Our Annual Meeting celebrated the hard work done by our team but mostly a celebration of the hard work and vitality of our persons served. These amazing individuals and their stories are an inspiration and a reminder of why we will continue to face any challenges that may arise to be their advocates and provide them with services that allow them to reach their own personal goals and aspirations.

Despite our need to acquire new funds for the Capital Campaign, FY 2014 was a record setting year with over \$160,000 raised from the Annual Appeal, which is the largest direct mail fundraiser and an imperative source of operating income. The Spring Benefit and Golf outing had terrific results with a record breaking number of golfers - 103. The Second Time Around Thrift and Gift Shop also continue to be a significant source of revenue to the agency with gross sales in excess of \$125,000.

Words cannot express the gratitude and pride felt for the entire Shore family of nearly 400 individuals served, and to our staff, board members, volunteers, families, and supporters. Thank you for allowing us to rise above and to continue our great work in 2015.

Vocational Programs

hore Joseph Koenig, Sr. Training Center in Morton Grove is a vocational program supporting persons with intellectual and other developmental disabilities ages 16 years and older. The program seeks to enhance the individual's ability to obtain and maintain employment. Objectives include: providing employment, maintaining job performance and improving job-related skills and habits to maximize earning potential. The Center utilizes community job sites and subcontract work from local industries to prepare individuals for employment. A Senior Services Program is also available for individuals (55 or older), who have chosen to retire. This program offers leisure-based and community activities.

- 177 individuals served during the year.
- The Sales Department had \$174,000 in contract work from businesses in the community, which is an 11% increase from Fiscal Year 2013.
- 15 persons served in the Supported Employment Program and 49 individuals were provided services at outside sites by the Community Employment Department (CED). The CED added a paper recycling program as a new site for community work experience.
- Direct Care Staff were celebrated during a week long recognition as a way to express appreciation for their fine work.
- Shore was selected as an Employment Network (EN) for the Ticket to Work Program, which provides people receiving Social Security benefits more choices for receiving employment services. Under this program, the Social Security Administration issues tickets to eligible beneficiaries who, in turn, may choose to assign those tickets to an EN of their choice to obtain employment services, vocational rehabilitation services, or other support services necessary to achieve a vocational (work) goal. We accepted our first Ticket to Work client and placed her in two jobs during the year.
- Through a grant from the Morton Grove Foundation, an art therapist from the Institute for Therapy for the Arts provided training to Koenig Center staff on topics for running group activities, which are now, part of the Skill Building Curriculum.
- For the fourth consecutive year, the center had a volunteer from the Jesuit Volunteer Corps (JVC) work full-time for one year as a Developmental Trainer. Ms. Danielle Manghera volunteered over 1,500 hours and was a tremendous asset to the program and interacted well with her group.
- Michael "Mike" Mack retired as Plant Manager after nearly 39 years at Shore. Diego Garcia was promoted to this position.







Adult Services

The Adult Services Program, which offers developmental training for individuals 18 years and older, is located at the Lois Lloyd Center in Evanston. Many of the participants have multiple disabilities, including severe/profound to moderate developmental disabilities and other physical and medical challenges. This educational program offers a curriculum in the areas of language and communication, adaptive daily living skills and prevocational skills.

- · 80 individuals received services.
- Over 300 community integrated activities included: museums, malls, parks, restaurants, concerts, stores and other places of interest took place. Persons served presented a play called "The Legend of Lightening Larry," and a Fashion Show to family members, staff and other stakeholders.
- Living a healthy lifestyle through the increase of fruits and vegetables and
 physical activity continues to be a main program goal. Persons served exercise
 or walk and many have decreased their body mass index. Since the program
 was initiated in 2011, persons served have lost 378 pounds. An exercise trainer
 from the McGaw YMCA conducted several sessions for persons served and
 staff on healthy eating and exercising, which staff has incorporated into their
 regular fitness program.
- Free monthly dental screenings continued throughout the year by the Illinois Masonic School of Dentistry.









Early Intervention

Early Intervention (EI) serves infants to three-year-olds who are experiencing developmental delays. Shore provides individual and group (occupational, physical, speech, and developmental) therapies in a variety of locations such as our El Center in Skokie, the child's home, or day care centers. The primary focus of the program is what is best for the child with input from their families. Research has demonstrated that working on prevention activities with children at a very young age is much more cost effective than remedial programs at a later age.

- 43 children received services during the year.
- A playgroup continues to integrate occupational and developmental therapy along with a Polish language translator. The group was started at the request of a Child & Family Connections Service Coordinator after seeing an increase in Polish families who could benefit from this service. A Spanish translator was also added to the playgroup to assist a child.
- The EI program collaborates with Wilber Wright Junior College's Occupational Therapy Assistant Program for eight weeks observing the therapists and helping with general office activities.
- National Lekotek, which is an agency that works with young children with developmental delays and collaborates with Shore's El Program, continues to share space at the El Center.



Residential Services

Residential Services comprises the Community Integrated Living Arrangements (CILAs), In-Home Respite Care and Service Facilitation.

Community Integrated Living Arrangements (CILAs) are homes in the community where two to seven people reside. The Jean F. Karger House and Laura House are located in Skokie and the Brown CILA is in Evanston. The program consists of an array of services designed to meet the needs of each resident on a long-term basis. Staff support is available on a 24-hour basis. Residents attend one of Shore's day programs during the week.

The Patricia Lloyd Townhomes (PLT) in Evanston and scattered-site apartments in Evanston and Skokie comprise Shore's Supported Living Arrangements (SLA) program. The PLT are a row of five two-story units, each housing two individuals that are available to adults who are able to live more independently. Eight individuals live in the homes and most are employed in the community. Residents are responsible for themselves and their homes. A House Manager resides in one unit to provide support as needed. The scattered-site apartment residents have intermittent contact with staff. Services are on an as-needed basis and training includes: budgeting, housekeeping, cooking, shopping, transportation, interpersonal counseling and case management.

In-Home Respite Care eases some of the stress families endure when they are the sole caregivers of a family member with a developmental disability. In-home training is provided that assists respite recipients with communication, self-care and social skills while enabling the primary caregiver to leave the home. Objectives are developed with the input from the individual, family members and staff, which are part of an individualized program plan. A family is usually assigned one respite worker to assure continuity. Hours for respite can range from a few

hours every week, to weekends or additional hours as needed.

Service Facilitation is provided for those individuals who are enrolled in the Illinois Home Base Support Services program. The program is designed to help individuals with developmental disabilities maintain community placement within their home. Shore's Service Facilitator provides case management and support for the individuals and their families including: identifying and assisting linkage to identified service needs for the person served. In addition, each individual is assigned a Personal Support Worker to assist them with their goals, which may focus on health, budgeting and other life skills.

- 63 individuals received services.
- Michelle Martinelli was hired in July as the Program Manager for Respite Care and Home Based Services.
- Many improvements were made throughout the CILA's that included: new flooring at the Jean F. Karger through the Village of Skokie Community Development Block Grant; renovation of a deck; resolving a moisture issue in a crawl space and adding personal touches to bedrooms with new bedding and artwork.
- A grant from the USG Foundation was received as program support for the SLA Program.
- As part of the health and wellness initiative, residents continue to eat healthy balanced meals and exercise regularly. For the first time, four SLA residents are training for the Special Olympics. This program has also been enhanced by connecting the residents with outside services that can come to their homes i.e. a Podiatrist, Social Worker and a Caregiver from the Department of Aging assists an elderly resident with housekeeping and meal preparation. The CILA program received dietary recommendations for all of our residents from a licensed dietician.





Shore Homes

The Buehler House/Shore Homes East in Evanston and Shore Homes West in Skokie each have 12 residents. The group homes are 24-hour staff supported living environments as similar as possible to life in mainstream society. Residents are encouraged to interact with their community and to learn to become less dependent on others. All residents are engaged in daytime employment, training or senior leisure programming.

- 24 residents received services during the year.
- Healthy living, with an emphasis on diet and exercise, continues to be in the forefront of all the residential programs. The residents exercise by riding the stationary bike and using the treadmill. Both group homes have a garden that includes: tomatoes, carrots, lettuce, corn, peppers, zucchini, cilantro, basil, onions, sunflowers, dill and pumpkins. The residents are responsible for watering the garden and the items are added to meals.
- Community integration outings took place during the year with trips to Tommy Gun's Garage, Blackberry Farm, Wild West Town, Mystic Blue Cruise, and picnics in the park.
- Alexandra Halilovac was hired as the Director of Shore Homes in February.

Since 1951, fundraising has played a key component in Shore's ability to offer the highest quality programs and services and to expand these offerings as the need arises. It is through the generosity of time, in-kind donations and financial support that has helped create the organization we are today.

- 19th Annual Golf Outing held at the Deerfield Golf Club in Riverwoods on Friday, July 19, 2013. 103 golfers attended an nearly \$11,000 was raised.
- A Capital Campaign Kickoff Party was held on October 16, 2013, at Found Kitchen and Social House in Evanston. Over 100 people attended the cocktail reception. Shore unveiled the new rebrand of its logo, tagline and website, which were designed by Glantz Design in Evanston.
- Annual Appeal set a new record with over \$163,000 received from 363 donors.
- Debora Braun, Executive Director, returned in January from medical leave. Deborah Shulruf, Director of Lois Lloyd Center, serviced as Acting Executive Director in her absence.
- Annual Spring Benefit called "Plant Your Dreams At Shore" took place at the new Fields Chrysler Jeep Dodge and Ram dealership in Glenview on Sunday, March 23, 2014. Nearly \$60,000 was raised.
- 207 volunteers provided 12,782 hours of service.
- Annual Meeting was held at Hackney's on Lake in Glenview on Tuesday, June 18, 2014, and featured numerous awards and presentations. See pictures for award recipients. In addition, Shore employees listed adjacently were recognized for having 10 or more years of service.
